Superintendent's Report

Superintendent Nugent reported on another Sussex Borough pipe break on February 25th, this one occurred along Route 23 corridor 30 feet from the last break. He noted that Ferraro Construction installed a repair clamp. This is the 21st pipe break, the Authority is aware of within the Sussex Borough sewer system. Discussions re: type of pipes used in the original specifications for construction. Chairman Petillo recommended contacting Sussex Borough and advising them of to perhaps sending out a sample of piping to be analyzed to determine why it is failing and causing these breaks. Mr. Nugent and Mr. Varro will reach out to Hauser Engineering re: analysis of the pipe material.

Mr. Nugent updated the Commissioners on the Hampton Commons Repairs, in which all brackets have been installed along with the extensions. He noted that a check was received from Hatch Mott MacDonald for \$10,850 which reimbursed the SCMUA for Ferraro Construction for the cost of installation of the correct brackets, which were required due to an oversight by HMM. Mr. Nugent reported he will review and prepare out of pocket costs to be submitted to the insurance company for further consideration.

Chief Engineer's Report

Mr. Varro reported on the Wastewater Engineer Consulting Agreements. Hatch Mott MacDonald submitted a proposal based on the Fair and Open Process in November of 2014, in which the agreement included an option for a one year extension. HMM have submitted a rate schedule for 2016 and a resolution has been prepared for Board consideration.

Superintendent's Report

Superintendent Sparnon updated the Commissioners on the E-Waste Price Quotes that were received, and they are very excessive. Mr. Sparnon reviewed his discussions with the vendors concerning what is included in their quote regarding packaging/materials and shipping costs and he reviewed last year's tonnages for E-Waste including revenue generated over the Authority's truck scale system throughout FY2015. Commissioners requested further analysis of the revenue tonnage for FY2015 to not include event tonnage, in order to establish a more accurate revenue amount that was generated. Mr. Sparnon acknowledged the use of the overall total tonnage of E-Waste (including events) should be used to predict total possible revenue generation for FY2016. Discussions continued regarding the acceptance of E-Waste Material

priced at ID13, as per current operations, and the State Legislature bill concerning Manufacturer's responsibility. Commissioners agree to hold off scheduling free event dates until they gather more information from our meeting scheduled this Friday with State Representatives and for further analyzed tonnage/revenues. Mr. Sparnon reported that in order to market/recycle E-Waste, it will require a Letter of Agreement with low quote vendor to remove the collected/stockpiled E-waste.

Commissioner Dietz thanked the Board for allowing him to phone into the meeting. Commissioner Perez thanked Mr. Varro and Mr. Nugent for his tour of the Wastewater Treatment Facilities, which he noted he was very impressed with the condition of the facilities.

Commissioner Cocula moved to adjourn the meeting, seconded by Commissioner Drake. On voice vote: Ayes (7), the motion passed. The meeting was adjourned at 4:16 p.m.
