#### a. Executive Session

### b. Wastewater Program

## Attorney's Report

Attorney Giacobbe reported on the status of the property Acquisitions for the Paulinskill Project which were submitted to the USDA and should be complete next week. He reviewed the necessary requirements for the subdivision and Mr. Afieri from his office is in the process of completing them. A preconstruction meeting is scheduled for tomorrow.

# **Superintendent's Report**

Mr. Nugent reported that the two year chemical bids are due to expire and asked for Commissioners authorization to prepare new bid specifications and advertise for the Wastewater Treatment Chemicals for 2015 and 2016. Commissioner Drake moved the authorization for advertisement of Wastewater Treatment Chemicals, seconded by Commissioner Meyer. On voice vote: Ayes (7); Nays (0); Abstain (0). The motion passed.

Mr. Nugent gave a report regarding the recent Sussex Borough Force Main repairs. Hardyston Township DPW notified Mr. Nugent and subsequently made the repairs. Discussion ensued on the multiple repairs needed since 1996 and condition of the sewage pipes, as well as and increase in flows for Sussex Borough during recent snow melt and rain events.

# **Chief Engineer's Report**

Mr. Varro reported that the property acquisition necessary for the Paulinskill Project which requires a subdivision for the construction of a pump station. He presented a resolution authorizing to submit an application to the Branchvillle Planning Board for the subdivision.

#### **Superintendent's Report**

Mr. Sparnon reminded the Commissioners that the first of four E-Waste Events is scheduled for this Saturday, March  $21^{st}$  from 7am - 2pm.

#### **Chief Engineer's Report**

Mr. Varro reported on the recent Solid Waste Advisory Council meeting that was held on March 10<sup>th</sup>. Points of discussion were regarding the proposed Grinnell Solid Waste Management Plan Amendment for the acceptance of ID13 Bulky Waste. The SCMUA prepared a position statement opposing the Amendment. The application was subsequently tabled by County Planning Director Eric Snyder in order for County Counsel to review further information and whether the Amendment will be processed at an Administrative Action or as a standard Plan Amendment with required Public Hearing. Discussions continued regarding potential loss of SCMUA Solid Waste Revenues, which would create a rise in tip fees, reductions in free/subsidized services for Sussex County Residents, and impact to payments on taxpayer backed bond payments. Further discussions re: SWAC's understanding of the Grinnell proposal and associated consequences to the Authority's wasteflow.

# Administrator's Report

Administrator Hatzelis reported on the Landfill Closure/Post Closure Care Audit. He discussed a draft copy of the Audit prepared by Ferraioli, Wielkotz, Cerullo and Cuva and detailed the many past events that contributed to the underfunded account. He explained that the proposed Landfill Expansion will help in reducing the deficit, as well as, an effective Solid Waste Enforcement Program.
