

**RESOLUTION AUTHORIZING EXECUTIVE SESSION**

WHEREAS, this Authority is authorized, pursuant to N.J.S.A. 10:4-12 to exclude the public from that portion of this meeting for purposes of discussing specific matters as permitted by N.J.S.A. 10:4-12; and,

WHEREAS, this Authority intends to discuss certain matters which are deemed confidential pursuant to N.J.S.A. 10:4-12, in Executive Session:

WHEREAS, at this time the Authority cannot determine the time when the discussion to be held in Executive Session will be made public but will disclose the minutes of the Executive Session when the need for confidentiality no longer exists.

NOW, THEREFORE, be it resolved by the Sussex County Municipal Utilities Authority that this meeting shall be adjourned to an Executive Session (closed session) and the public will be excluded in order that the Authority may discuss the items listed below, and upon reconvening this public meeting the Chairman will announce, if possible, the time when and the circumstances under which the discussion conducted in Executive Session will be disclosed to the public. This resolution is authorized and allowed by and pursuant to N.J.S.A. 10:4-13.

(1) Any matter which, by express provision of federal law or State statute or rule of court shall be rendered confidential or excluded from the provisions of subsection a. of this section.

RESOLUTION RE: AUTHORIZATION TO EXECUTE CONTRACT AND  
RELATED DOCUMENTS WITH ELIZABETHTOWN GAS

WHEREAS, the Sussex County Municipal Utilities Authority (SCMUA) has a need for the provision of natural gas service at its Lafayette location; and

WHEREAS, Elizabethtown Gas is in the process of extending its gas service lines down Route 15 South; and

WHEREAS, Elizabethtown Gas is further considering a 6" diameter extension up Route 94 North along current SCMUA property; and

WHEREAS, Elizabethtown Gas has proposed a Non-Residential Gas Extension Contract to enable the proposed Route 94 extension and gas service to the SCMUA Administration and Solid Waste Facilities; and


WHEREAS, the proposed Gas Extension Contract is at no cost to SCMUA, if however the SCMUA commences utilization of the gas service within twelve (12) months of completion of connection; and

WHEREAS, the proposed Elizabethtown Gas Extension Contract is in the best interest of SCMUA.

NOW, THEREFORE BE IT RESOLVED by the Commissioners of the SCMUA that:

1. The SCMUA Executive Director is authorized to execute the Non-Residential Gas Extension Contract with Elizabethtown Gas, and any other endorsement or approvals necessary, in this regard.
2. The SCMUA Executive Secretary/Office Manager shall witness and countersign the Contract.
3. This Resolution shall be effective in accordance with NJSA 40:14B-14(e).
4. A copy of the Resolution shall be provided to Elizabethtown Gas.
